Activities

2009-2010

To review Curriculum, support Faculty Development and to facilitate interaction between Professionals and Architecture Schools, Ar. Syed Akeel Bilgrami proposed and spearheaded formation of Board of Architectural Education (BAE).

The objectives of the Board, its constitution and various sub committees were finalized in a meeting held in March 2010 with full quorum (i.e. the head and another representative from all the seven PCATP recognized architecture schools participated). Since then BAE-IAP has facilitated exchange of information amongst the schools, encouraged dialogue and disseminated information and news of scholarships, competitions international seminars and workshops for students. During the year, five more schools accredited by PCATP, have joined the BAE-IAP.

2010-2011

The Board of Architectural Education, established formally in 2010, has until now acted as a post box, disseminating amongst all the accredited institutions, international news, announcements, students' design competition documents

and other relevant news and information. The highly successful organization of the ARCASIA Students' Jamboree at Lahore in October 2010 was due to the participation and efforts of members of BAE-IAP who are heads of departments of all the accredited architecture schools. It is however unfortunate that BAE-IAP has been unable to act more proactively in educational and student affairs, mainly due to Poor response from BAE-IAP members.

2011-2012

The Board of Architectural Education – Institute of Architects Pakistan now comprises of the Heads of Departments of the 15 accredited architecture schools in the country. Apart from disseminating amongst all the institutions, international news, announcements, students' design competition documents and other relevant news and information, BAE-IAP has embarked upon a series of activities during the year.

BAE-IAP, Faculty Training Workshop was held on April 29, 2013 at Islamabad in which Prof Nuno and Prof Daniell of Macau conducted the workshops.

2013-2014

The Board of Architectural Education (BAE) comprises of the Heads of Departments of all the accredited schools of architecture in the country (current strength: 15). It is chaired by a member of the National Council specifically appointed to that position.

Foreign Contract for Historic Preservation (November 2013)

Meeting with Foreign Architects on Historic Architecture Preservation

Attended the meeting conducted by BAE-IAP on 19th November, 2013 in which the objectives and goals for their 3 years contract were discussed. This joint venture with National College of Arts and Boston Architectural College has been planned to foster sustainable terms on international level in

Architecture and to provide support in conservation of buildings having historic importance in Pakistan. Furthermore, architects exchanged their views about future plans related to the comparison of Architectural studies between different colleges and Countries.

BAE-IAP 2nd Round Table (March 2014)

The second Roundtable Conference was held on 15th March, 2014 focusing on a Weeklong International Conference planned to be conducted in October 2014. The conference was attended by Heads of Department and their representatives of 20 Schools of Architecture in Pakistan of brainstorming for an initiative which will hold great significance in nurturing Architectural Education nationwide.

- Create an online discussion group of Curriculum and Distinct thesis projects.
- Papers to be shared by teachers should be open to other institutes which can create diversity of ideas

International Conference on Architectural Education in Pakistan

(October 24 to 31)

- At the 2nd Round table held at Islamabad in March 2014, all 20 participating schools decided to hold a conference under the aegis's of BAE-IAP in order to revisit and enhance their curriculum in order to bring it at par with the International standards, keeping the regional context in mind.
- All school committed to be on the steering committee to work together with the BAE-IAP to put together this event which will focus purely on "Architectural Education" in our country.

Salient Features of the Event:

• HOD's Conference:

Interaction of all HOD's with each other on the curriculum development of each school including the participation of foreign delegates well-versed with our issues in education, in order to take it par with the International level.

Mid-Level Teacher Training & Exchange Program:

- 2nd leg of the Teacher Training Workshop, inviting 80 teachers from all 20 (-+) schools, to be instructed jointly by both foreign and local instructors in this event. This should take place every 4 months, from then onwards in order to be able to build capacity of our teachers to the required level. Schools to shortlist the teachers according to established auidelines.
- Pakistani teachers will be selected to be sent to foreign universities, in exchange of their faculty coming and teaching in our schools.

Student Charrette:

• All schools to participate in Student Charrette during this conference in order for them to be able to interact and get input from the visiting delegates on their work.

Awards & Scholarships:

BAE-IAP to give awards of recognition to be selected:

- Educationists
- Practicing Architects
- Students

Scholarship for Students:

BAE-IAP to announce need- based scholarships to students from various schools. A sustainable model will be presented to ensure that this becomes a permanent annual feature of BAE-IAP towards enhancing our Education system.

- A working paper covering the themes, timelines and committees is being prepared with the input of all schools.
- This should be ready by end of June 2014 and will be shared with all concerned for their input.

<u>2014-2015</u>

BAE-IAP Faculty Roundtable

We shall form an Association of Faculty of Architecture at institutional, chapter and national levels and formulate a Charter for its operation', was the highlight of the resolutions passed by 31 faculty members from all across Pakistan at a Roundtable facilitated by Board of Architectural Education of the Institute of Architects Pakistan (BAE-IAP). For the first time in the history of architectural education in Pakistan, a talented group of young faculty from across Pakistan was able to interact and form connections with renowned

architects and amongst themselves. To ensure inclusion of all accredited schools the list was prepared in consultation with the Pakistan Council of Architects and Town Planners (PCATP). Out of the 23 invited institutions 16 participated. In all with school nominees and those from IAP Chapters, the 3-day successful Roundtable had 31 participants.

Moderated by Ar. Khadija Jamal, the group of young faculty showed amazing energy and enthusiasm and quickly set the pace for discourse on issues pertaining to Architectural Education in Pakistan. This signaled the success of the Agenda that BAE-IAP had set for the Roundtable even earlier than imagined. By providing this rare platform to the young faculty, BAE-IAP met with success in:

- The young faculty benefiting from the experienced guest speakers from pertinent fields but diverse subjects.
- Engaging the young faculty to voice their concerns of all aspects of architectural education and seeking means of addressing them.
- The young faculty realizing that they needed to work together to overcome these problems and BAE-IAP would provide full support.

In his welcome address, Chairman BAE-IAP Ar. Murad Jamil described very briefly the role of Board of Architectural Education – Institute Of Architects Pakistan (BAE-IAP) and informed the participants about its focused efforts in the light of the Charter. He explained that 3-day event offers an exclusive opportunity to meet some esteemed speakers and develop networking amongst institutions across Pakistan.

The President IAP S. M. Jahangir Khan enlightened the audience with the initiatives of BAE-IAP; bringing all Heads of Architectural schools to one platform. He shared thus far that

82 teachers have been trained as a result of faculty training workshops.

Welcoming the participants to a city by the sea, the IAP Karachi Chapter Chairperson Ar. Komal Parvez thanked the Core Committee for providing the Chapter with an opportunity to host the event. She told the faculty that they were the VIP(s) of the show since they are the ones who will shape the future of Architecture in Pakistan.

Ex-Chairman BAE-IAP, Ar. Syed Akeel Bilgrami informed the participants that BAE-IAP has put in enormous effort to make the event a big success. He said that it is now up to the faculty to take sincere interest and contribute to architectural education in the country.

In his address, Core Committee Member, Ar. Shahab Ghani Khan recalled the role of IAP in promoting architectural education as early as in the 50's. He appreciated the efforts of BAE-IAP in promoting and capacity building of faculty at Architectural schools across Pakistan.

A keen exchange of ideas motivated the participants in the first round and set the house in motion for further proceedings. In following 3 days, prominent architects including Ar. Yasmin Lari, Ar./ Plnr. Sikander Ajam Khan, Dr. Shahzad Jeewa, Prof. Dr. Noman Ahmed, Ar. / Plnr. Arif Hasan and Dr. Gulzar Haider interacted with the Roundtable participants. They revealed certain attributes of a faculty to become a successful teacher in the field of architecture.

On the concluding day of the event, all participants at a closing dinner presented a resolution of their 3-day deliberations on various issues of Architectural Education in

the country. In the presence of Prof. Dr. Atta-ur-Rahman, the Chief Guest of the occasion, the Roundtable facilitator Ar. Khadija Jamal appreciated the efforts of BAE-IAP for providing a platform for faculty from all over Pakistan to discuss issues regarding architectural education in a focused manner. She invited one of the Roundtable participants Ar. Nabah Ali to declare the resolution before the august audience.

The Chief Guest then presented mementos to all guest speakers and certificates to all participants, volunteers and BAE-IAP Coordinators as a token of appreciation for their heartfelt involvement in the Faculty Roundtable. The evening came to an end with a vote of thanks by the Chairperson IAP Karachi Chapter Ar. Komal Parvez.

BAE-IAP Faculty Capacity Building Workshop.

IAP ARCASIA Young Teachers Training Workshop, Karachi Institute The of Architects, Pakistan continued its determination to improve the Architectural Education in Pakistan with the number of schools added each year and lack of trained studio teachers, a series of international workshops have been conducted in the last four years with Ar. Prof. Nuno Soares and Ar. Prof. Thomas Daniell in July, 2013, October, 2014 and February, 2016 respectively under the banner of IAP, BAE and ARCASIA which were a huge success. The Workshop was called "Designing the Studio". In the latest addition held in February 2016, 15 teachers from 9 schools were trained including 2 from Sri Lanka taking the total of all teachers trained in this workshop over the past couple of years to over 110. These workshops initiated under the IAP presidency of now President Elect ARCASIA, Ar. S.M. Jahangir Khan who made a significant contribution by IAP towards architectural education. This year, the workshop was taken a step further with the introduction of the master teacher training workshop. This was a challenging experience and was a first step towards developing eventual master trainers in the future. A total of 8 participants from all over Pakistan took part in this new workshop.

The workshop was held from the 8th to the 12th of February, 2016. The participants of both workshops were continuously engaging with the instructors and produced short

presentations daily, culminating in a group project for the teacher trainers. For the master teacher training workshop, the participants designed the curriculum for an entire semester on an individual basis. The two workshops concluded with a closing and award ceremony.

Taking advantage of Prof. Thomas Daniell's presence in Karachi, the chapter promptly organized an enlightening lecture on highlighting the role of female architects in the development of Japanese architecture. This workshop was hosted at the Beach Luxury Hotel by the IAP - Karachi Chapter under its Chairman, Ar. Arif Changezi. It was organized by BAE-IAP, under the Chairman, Ar. Arshad Faruqui. Honorary Secretary IAP, Ar. Ramiz Baig was the convener of this week-long workshop.

IAP-Kausar Bashir Ahmed Award 2016, Karachi

Sixteen entries of the eighteen received were anonymously presented to the Jury. The jurors shortlisted four projects which seemed close to the philosophy of the Award for further review and deliberations and unanimously declared the thesis titled, 'Socio-Economic Upliftment of Lyari Community through Reorganization of Spaces' by Ms. Sana Hameed of NED University as winning entry. An honorable mention was given to Mr. Farrukh Ahmad Salman of Indus Valley School of Art and Architecture for his thesis titled. 'Panah-e-Salik'. The announcement was made by one of the Jury members, Ar. Khadija Jamal Shaban at a graceful ceremony held on April 24, 2016 at Gala Night on the occasion of IAPEX Karachi. Jointly instituted in 2012 by IAP and KBA - CARE (Kausar Bashir Ahmad Center for Architecture, Research and Education), IAP-Kausar Bashir Ahmad Award is conferred annually to the best thesis design work in the domain of socially responsive architectural design. All accredited schools imparting architectural education in Pakistan are invited to send maximum two nominations for this Award. The Award comprises of a gold medal and Rs. 25,000/= cash prize. This year, it was the fourth cycle of the Award for the year 2015-16 hosted by IAP-Karachi Chapter. The Award conferment took place during closing session of IAPEX Karachi in the presence of prominent architects from Pakistan, students,

faculty and building industry representatives. To enlighten the participants about the life-long achievements of Prof. Kausar Bashir Ahmad, the President KBA - CARE, Prof. Dr. Noman Ahmed made a brief presentation titled, 'Professor Kausar Bashir Ahmad: Contributions, Impacts and Legacy'. He unfolded many aspects of Kausar sahab's life as an artist and shared some of his oil paintings that still adorn the Middle East Technical University Library at Ankara. Dr. Noman told the participants that Kausar sahab not only served the institutions as an educationist, but he possessed good qualities of leadership to build institutions. His quest for searching new knowledge produced many scholarly papers. Besides this, he used to write poems encompassing various topics including the prevailing social unjust in the society. "Socially responsive architecture was considered as the core philosophy adopted and promoted by Kausar Bashir Ahmad", said Dr. Noman who further told the participants that Kausar sahab believed that the profession of architecture should not be confined to a particular segment of the society. "Socially Responsive Architecture offers a platform where architects become a part of the community of social entrepreneurs," explained Dr. Noman Ahmed. Describing the vision of Kausar sahib for architectural education in the society, Dr. Noman highlighted that Kausar sahab was a great promoter of incorporating spirit of new age with humanistic values, enabling architects to develop expression across modern times, integrating indigenous traditions in research and equipping architects to evolve individual contribution as an expression of the whole society. His presentation was followed up by a digital screen display of the nominations received for this Award by the Award Convenor, Ar. Farida Abdul Ghaffar, She briefed about the Award process and the jury which was composed of following professionals:

She informed the participants that 18 accredited schools of architecture throughout Pakistan were invited to nominate the best thesis projects under the domain of Socially Responsive Architecture. Maximum two entries were requested from each school and in return they received 18 entries from 12 schools. Two nominations were disqualified due to late submission. Others included:

After presenting all entries before the audience, Ar. Khadija Jamal was invited to announce the winning entry and read citations as concluded by the jury. The winner, Ms. Sana Hameed was presented with a cash prize and a gold medal and Mr. Farrukh Ahmad Salman was given a Certificate by the President IAP, Ar. Ali Zafar Qazi accompanied by Chairman IAP - Karachi Chapter, Ar. Arif Changezi, Chairman BAE-IAP, Ar. Arshad Faruqui and President KBA – CARE, Dr. Noman Ahmed.

CITATION: Citation for winning entries was read out by Ar. Khadija Jamal as follows: **Sana Hameed** of NED University of Engineering and Technology, Karachi is awarded the KBA Award for the most outstanding Thesis Project on Socially Responsive Architecture titled Socio-Economic Upliftment of Lyari Community through Reorganization of Spaces. The Citation states that the:

- 1) Design turns around an existing dilapidated building in the heart of Lyari which is already an existing place for community and street activities.
- 2) The re-use of the building and additions to it not only cater to street activity in a more organized manner but also add and enhance the quality to its social environment.
- 3) Additions to the building also include a theater which revives a space for a street activity that previously existed in Lyari.
- 4) The architecture is modest and the design interventions respect that modesty in a sensitive manner.
- 5) Finally the project is realistic and if executed will go a long way in providing the Lyariites a possibility of healing the wounds of conflict. Architectural details have also been worked out diligently and indicate a depth of understanding of the physical and social context. The presentation communicates the research work and design concepts very clearly through well-presented sketches and 3-D images.

The honorable mention is given to Mr. Farrukh Ahmad Salman of Indus Valley School of Art and Architecture for his thesis titled, 'Panah-e-Salik'. It was a difficult subject giving the nature of the social taboo involved in rag picking activities and its relation to urban space for habitation purposes. The student has accepted the social realities and he, without trying to impose his own views on how the activities of the

groups should be carried out, suggests restructuring of the spaces they use. The design essentially consists of reorganizing the living spaces around their most popular 'place of work' near garbage dumps below the city flyovers and bridges using mostly re-cycled material. The project has been dealt with much sensitivity and design aesthetics through a consistent thought process. The jury felt that while it would organize the target group it will cause formalized degradation to the urban fabric and the environment.

ARCASIA Students' Architectural Design Competition 2016

Introduction

This is a design ideas competition that invites students in the field of Architecture to contribute ideas and concepts that respond to the theme "Green Lifestyle". Each country is facing their own sustainability concerns and students are encouraged to identify, at the same time resolve, these issues by using architectural designs.

Objectives of the competition

Students are free to select a site to come up with design ideas, built or portable or a prototype, which would encourage users to participate in a green and sustainable lifestyle. Students are encouraged to think along lines of cost effectiveness, energy efficiency, low carbon footprint, zero carbon emission and implementable means that may resolve an identified problem found in your particular region of Asia, or one which might even be effective when adapted in many different situations.

For this year's competition, IAP received the following entries:

- 1) Sustainable Approach to Urban Agriculture by Abdul Wasay, University of Karachi
- 2) Eco Shelter by Arsalan Khan, University of Karachi

In 2009, Institute of Architects, Pakistan (IAP) in its endeavors to raise the standard of 'ARCHITECTURAL STUDIES' Graduate Level in Pakistan instituted the 'IAP GRADUATE AWARDS FOR ARCHITECTURE' in order to encourage and acknowledge "Exemplary Final year Architectural Thesis Work" from amonast all accredited schools of Architecture within Pakistan. The Graduate Award envisages the enhancement of the awareness of the role of students of Architecture in the socio-economic and cultural life of the country. The IAP Graduate Award intends to demonstrate that Graduate Studies in Architecture should be seriously taken by the students and that good architecture is a major component of the positive influence on the human environment, and that physical development in Pakistan need not be in disharmony with the cultural values, national identity and the natural environment of the country. This year, the 8th cycle of the Award received twenty-nine entries which were anonymously presented to the Jury. Initially nine projects were shortlisted and subsequently four were selected for further review and deliberations. This resulted in the jury's recommendation for one award and two honorable mentions. Jurors found a number of interesting projects, but often the objectives were not clearly defined and did not lead to a viable research agenda. In addition, in many cases, the architectural design response was not sympathetic to the physical and social environment.

Arshad Faruqui read the citation of the winning entry and invited Rabeeya Suhail Arif of Beacon House National University, Lahore for the most outstanding Thesis Project titled 'Sanctuary of Thought: Revealing the Palimpsest - Travelling back to the origin' to receive her Award from President IAP, Ar. Ali Zafar Qazi. She was awarded a gold medal and certificate.

MEHDI ALI MIRZA AWARDS:

The Mehdi Ali Mirza Award is named after a person who laid down the foundation of professional architectural practice in a newly emerged country which had less physical and institutional infrastructure. Born to an officer of the forest service in Hyderabad State. British India in 1910, Mehdi Ali Mirza was amongst the first generation of formally trained architects in Pakistan. Upon his migration to Pakistan right after the formation of the new state, he was designated to a principal government post in the Public Works Department. Here, he soon realized he could achieve little with the untrained, disorganized workforce he had been provided. To ensure that he had a qualified team to assist him in various tasks, Mirza set about laying the foundations of the first institute in the country imparting professional architectural education, the Government School of Architecture. Eventually, with the assistance of few colleagues, he set up the Institute of Architects, Pakistan in 1950, and the first regulatory framework for the profession in the country. In 1962, he was awarded the Pride of Performance. After 13 years of his death in October 1961, the Mehdi Ali Mirza Award was instituted in 1984 by the Institute of Architects, Pakistan (IAP) in memory of the Founder and First President of IAP. This Award gives recognition each year to the students from each accredited architecture school within Pakistan who have excelled in their studies and graduated securing top position with the highest marks (Cumulative GPA of all five years) in their respective school. This year 19 nominations were received from 18 accredited schools within Pakistan as follows:

These awards go through an extensive process of selection and organizing of the jury and scrutiny of the submissions and the results are announced at an official ceremony. Two of these awards are selected through a jury while the Mehdi Ali Mirza Award is awarded to the students with the highest cumulative GPA in the degree program from all accredited institutions. This process aids the BAE-IAP to manage a descriptive database which is integral to assessing the standards and improving where need be.

Mehdi Ali Mirza Awards are conferred by the Institute of Architects Pakistan (IAP) to the top achievers of graduating batches from the schools of Architecture in Pakistan every year. The Award recognizes outstanding achievement of students with the highest cumulative GPA of a five-year study in Architecture. This year 18 students were given the award from various schools of Architecture in Pakistan. Awards ceremonies took place at Karachi, Lahore and Islamabad in April and September 2017.

1st BAE-IAP Photography Competition- "The Process", Karachi First Photography Competition Exhibition was organized by BAE-IAP (Board of Architectural Education, Institute of Architects Pakistan). 'The Process' was the title of the First Photography Competition for the students of architecture

from across Pakistan. 59 contestants from 18 schools across Pakistan submitted their photos and total number of exhibits on display touched a figure of 176. The photos captured a wide variety of subjects under the domain of 'Process'.

The BAE-IAP Chapters Roundtable Meetings

Three images were shortlisted as 1st, 2nd and 3rd winners whereas two honourable mentions were given to two entries with one special award for capturing best colors in the photo.

Roundtable Meeting with Hods from schools in Sindh and Baluchistan, KARACHI

The HoD's of nine schools of architecture in the domain of IAP-Karachi Chapter from Sindh and Baluchistan were invited to a roundtable meeting by BAE-IAP Chairperson Ar. Khadija Jamal Shaban to discuss various matters pertaining to the quality of education in Pakistan. The meeting was held on 2nd March hosted by IAP-KC during IAPEX. The Hods were

This year 10th Cycle of IAP Graduate Award was successfully executed. 32 entries were received from 13 accredited schools across Pakistan. The Jury for the 10th IAP Graduate Award 2017-18 was held on Monday, 19th March, 2018 at the IAP Office in Lahore. Thirty two entries were reviewed and assessed by the jury comprising of Ar. Sajida Vandal and Dr. Syed Tauseef Ahmed (Academics), Ar. Syed Mohammad Irfan and Ar. Raza Ali Dada (Practice), Ar. Ali Zafar Qazi (President IAP) and Ar. Khadija Jamal Shaban merit (Chairperson, BAE-IAP). The Jury found recommending two winners as the two projects, 12 IAP Country Report - ACA 18, Tokyo, JAPAN though diverse, managed to bring to fruition and completeness the research and ensuing design. Both the winners belong to NUST School of Art, Design and Architecture, Islamabad.

6th Cycle of IAP-Kausar Bashir Ahmad Award Jury, LAHORE

IAP Kausar Bashir Ahmad Award is conferred annually to the best Thesis Project among all accredited architectural schools in Pakistan in the domain of Socially Responsive Architectural Design. This year for 6th Cycle of the Award, 19 entries were received from 10 accredited schools across

Pakistan. The Jury was held on Monday, 19th March at the IAP Office in Lahore. Eighteen entries were reviewed and assessed by the jury comprising of Ar. Fauzia Qureshi, Ar. Abdul Qadir (KBA Care Nominees), Ar. Taimoor Khan Mumtaz (IAP Nominee), Ar. Ali Zafar Qazi (President IAP) and Ar. Khadija Jamal Shaban (Chairperson, BAE-IAP). The Jury selected one project from Indus Valley School of Art & Architecture as the winner whereas two thesis projects from NED University and Indus Valley School received honorable mentions.

Roundtable Meeting with Hods from schools in Punjab, LAHORE

The HoD's of all schools of architecture in the domain of IAP-Lahore Chapter from Punjab were invited to a roundtable meeting by BAE-IAP Chairperson Ar. Khadija Jamal Shaban to discuss various matters pertaining to the quality of education in Pakistan. The meeting was held on 20th March hosted by the University of Lahore at their campus. The Hods of relatively new schools requested BAE-IAP's assistance in refining curriculums. The house under the theme of 'Plan Together' emphasized the need of conducting Faculty Trainings on a regular basis to enhance the capacity of the younger faculty.

BAE – IAP Round Table on Architectural Education, KARACHI

The Board of Architectural Education, Institute of Architects Pakistan organized a round table session on architectural education on 26 June 2018 at a local hotel. The objective of holding this session was to appraise the past and present scenario of architectural education to tread in to the future. The session was held after substantial pre-event preparations. BAE-IAP Chair, Architect Khadija Jamal Shaban liaised actively with many senior academics and professionals with

an interest in education to contribute their thoughts and ideas before and during the session.

On the day, Khadija introduced the intent and purpose of the event. She gave an over view of the architectural education scene in the country. Prof. Dr. Noman Ahmed, Dean, Faculty of Architecture and Management Sciences gave presentation on the subject. It was based on a position paper that was written by him and circulated before the event. The presentation covered a broad range of issues connected to architectural education including historical background and geographical context, evolution of architectural profession and education, early students, teachers, society and more, early challenges and responses, key determinants architectural education, timeline [1970s to 2018] and core developments, the institutional context, interface and influences from abroad, Statutory and professional bodies, knowledge resources related to local context, challenges and opportunities. He also presented an agenda for discussion. Architect Muhammad Fazal Noor, Head of Architecture Department at Sir Syed University, gave a presentation on governance issues in relation to architectural studies. He stressed that architectural education shall greatly improve if some contemporary 13 IAP Country Report options – such as outcome-based education adequately applied and examined. There was an open discussion wherein eminent architects and academics participated. Many useful outcomes came out during the discussion which are being compiled and circulated leading to further deliberations on this theme.

BAE-IAP & HOD Meetings - Lahore (Session One)

BAE - IAP with collaboration with Department of Architecture - Comsats University, Lahore Campus organized a discussion on "Selection Criterion of Thesis Topic" at COMSATS Lahore campus in which 10 universities participated. Each institute was represented by their respective architectural school's HODs and their Thesis Advisors. The agenda of the meeting

was to discuss the selection criteria of the Thesis at Bachelor's level in each university involving better ways of conducting research and thesis, forming and agreeing upon a common ground to help maintain the quality of education and work in all Architectural Schools.

Ar. Umar Saeed then began the meeting by Bismillah and headed over to an introducing CAA - Commonwealth Association of Architects i.e. An organization for professional bodies representing architects in Commonwealth countries to promote co-operation for 'the advancement of architecture in the Commonwealth' and particularly to share and increase architectural knowledge.

Ar. Umar Saeed recently been inducted as the Vice President of Asia and hence this new post should help with the spreading of influence worldwide and also use the CAA's vast data bank on the similar issues that our local architectural community is facing. Bridging up the gap between Local Architectural Community and International

Architectural Community, enhancing the standards of Architectural Education as well as Architectural Profession. The Chairperson then invited each university to give a presentation on how they conduct thesis in their institutes. After presentations almost all of the universities had a similar way of proceeding with the thesis.

Few things that were opened for debate were as follows.

- It is a general observation that students find it hard to make up a research-based question for their thesis.
 Therefore, a discussion about the possibility of a mini thesis was discussed to give students a chance to deliver a project based on their own research before the main thesis. This could be carried out in third year.
- Everyone agreed to the simple notion of thesis project being an "Architectural project with emphasis on any subject of student's interest" and the project must have all the layers that students have been taught in previous 4 years with a minimum submission criterion met by all students.
- Suggestion about revising the grade splitting among the internal thesis advisors and external jurors of 40-60 ratio applied by PCATP.
- The scope of work is not defined and is based on the detailing of work. For example, if a project's scale is small the detailing would be intricate as compared to a project of a bigger scale.
- In the final presentation of the project the visibility of the research work i.e., the work from 9th semester should be way less than the final product display.

BAE-HOD Meetings - Lahore (Session Two)

BAE – Board of Architectural Education in collaboration with Department of Architecture Lahore College for Women University, organized a discussion on "Accreditation process & its perimeters" at LCWU in which 9 universities participated. Each institute was represented by their respective architectural school's HODs and their 1 Faculty member. The list of the universities is as follows

The meeting started with recitation from Holy Quran and BAE-IAP's chairman Ar. Umar Saeed gave a general introduction and purpose of the meeting to the attendees. It was specifically mentioned that PCATP is as a statutory authority and IAP is its working arm. Further, BAE-IAP is a platform for HOD's of all Architectural Schools, where they can collaborate to share their ideas, discuss the issues faced, propose solutions and work together for the advancement and betterment of Architectural Education.

The purpose of the meeting was to provide an open environment to discuss the issues faced by Institutes during the Accreditation process, highlighting the status of PCATP, proposing solutions and agreeing collectively so the same can be proposed to PCATP for review and discussion with the accreditation Board.

Each Institute was given 5 minutes to express their issues and their proposed solutions. Below are the points raised by the Institutes.

It is felt that there is a lack of communication between the Institutes and PCATP throughout the process of Accreditation and elsewise. Institutes are not informed regarding new rules which creates lack of awareness. Further, there is incomplete information in terms of what things are required to be done, time of action and implementation etc.

It was proposed that involving all stakeholders and institutes while making decisions related education and institutes will help building a stronger network and enhance understanding.

- o It is a general observation that the website is not maintained well and updated, followed up by technical errors and flaws in forms and documents (e.g., AC-2) which is causing difficulty for Institutes to process their information.
- Institutes are finding it hard to bear high funds and fines. It was suggested that consideration of Institutes position, sector, budget and circumstances while establishing new rules, funds, fines, might help achieving a much-needed flexibility.
- Every Institute is bound by its own tangible and nontangible assets, it takes time in implementation and execution of new rules. It is requested to the authority to provide adequate time in which the Institute can perform necessary actions.

- Intra-authority interaction is felt to be missing between Education Nominee, the Inspector, and the Board.
- Inspectors are believed to be very prominent part of the fraternity, it is requested to know what is the criterion of selection, qualification, experience, standing and appointment of the Inspector, so that Institutes may help by suggesting some names.

Institutes and PCATP should work together for the enhancement and development of Architectural Education. Institutes should be kept involved and updated throughout the process of accreditation so that they can help out the PCATP wherever required.

- Institutes requested to have a collaborative approach in funds and fines management and spending, so that they can help by suggesting the areas in education sector which require investment and amendment.
- There is seen lack of uniformity between HEC & PCATP.
 HEC requires to update its curriculum which the Institutes are instructed to follow.
- o The Institutes are trying their best to maintain and ensure the quality of education for every student that has come to learn, by appointing well qualified teachers on merit and balancing the teacher to student ratio that is suggested by the PCATP. The authority is requested to reconsider their decision on maximum number of students being 45 considering dropout rate, criterion 45; PEC.
- It is suggested that Masters is a specialized degree, with one major research subject, which is effective and effectual for the Institutes as well as the students as they appoint specialized and expert teachers for

specific subjects. PCATP should rethink their decision regarding Masters-Specialization in Architecture for senior faculty positions and some further clarification is required in faculty hiring criteria.

There is a need for a well-structured system, proper channelization and legitimate documentation. In addition, the Institutes need PCATP's support and encouragement throughout for their growth, development and success.

- It was requested that the good standing of the jurors may kindly be explained as it seems to be a little confusing.
- o It is observed that the self-assessment document provided by the council is not transparent and even though most of the institutes consider themselves accredited according to it, Council's decision comes otherwise. So the self-assessment document needs to be updated and properly implemented.
- Another good suggestion was to have workshops between PCATP, Inspectors and HODs as it is being felt that inspectors are sometimes not following standards set by the council but are following their own inspection strategies which creates a major disconnect between the Council and the institute.
- Nomenclature of degrees and their association with different schools is also something we are generally confused and with consultation with institutes, Council may agree which school the department of Architecture belongs to.
- Institutes wants clarity about the Licensing Exam and are requesting either PCATP or BAE-IAP to conduct seminars on the licensing exam, its outline and

- complete criteria so the institutes can actually inform their students.
- o It was suggested the Professor of Practice should be allowed to be inducted in the institutes as all institutes believe that there has to be a mixture of Academics and practice in a program for it to offer the holistic approach to its students.
- Initiation of Architectural Journals were requested to PCATP as well as BAE-IAP so it can provide platform to Architectural scholars to express their findings. nationwide database Develop а of theses. documentation of local precedents and competitions repositories for all schools and registered architects to access from any part of the world. However, the journals must be recognized by HEC vide HJRS as well as Scopus and other international standards - in a good category accepted for BPS appointments at HFIS.

BAE-HOD Meetings - ISLAMABAD | RAWALPINDI

BAE-IAP in collaboration with IAP Rawalpindi – Islamabad Chapter organized a discussion held at IAP-RIC Secretariat, Islamabad, in which 6 universities participated. Each institute was represented by their respective Architectural school's HODs and their 1 Faculty member.

Each Institute was given 5 minutes to express their issues and their proposed solutions. In Continuation of prior comments already shared in proceedings of Lahore meeting, below are a few additional points raised by the Institutes:

- There are certain points in infrastructure requirements laid down by PCATP that need serious reconsideration.
 - Computer lab for 45 students. Presently almost all students work on their laptops. This requirement could be modified to establish research focused labs or labs with fewer capacity.
 - 2 lecture halls. Most theory courses are conducted in the studio space so the lecture hall requirement could be reconsidered.
 - Model making lab. The concept of digital visualization and VR capabilities has reduced the use of model making to the minimum. The schools should be encouraged to establish 3d printing and laser cutting capabilities.
 - 1500 books requirement for the departmental library. The concept of library has changed. Digital repositories of pdfs should be encouraged rather than huge spaces for a few books.

PCATP is expected to be inclusive and cognizant of the disparities between the financial and social aspects of Institutes that are in different regions within Pakistan.

 By limiting the degree requirements to ONLY architecture, PCATP inadvertently ends up creating professionals with extraordinarily little to contribute to the dynamic and evolving architectural profession.

- Moreover, this clause is detrimental to the growth of academia as well. The criteria would exclude indispensable professionals from allied fields to contribute to holistic architectural education. To respect the globally accepted concept of transdisciplinary and multidisciplinary architecture pedagogy it is imperative to keep it flexible by including all relevant fields to Architecture.
- Another critical point is the fulfilment of basic accreditation criteria, particularly senior faculty posts (Professors and Associate Professors). The Institutes advertise the vacancy and share it through social media, print media, personal contacts, and every possible way, the seats remain unfilled since no one meets the HEC/ PCATP criteria for the positions, and also no one at this senior stage of his or her career wants to relocate to another city. It is requested to PCATP to support institutes in identifying suitable individuals for senior posts (A pool), who would then apply for the advertised positions and be selected if they fulfil the criteria.

PCATP & Institutes Meeting

PCATP in collaboration with BAE-IAP organized a discussion held at Maisonette Hotel in which 11 universities participated. The meeting was attended by Chairman PCATP Ar. M. Arif Changezi, President IAP Ar. Saad Mehmood Khan, Chairman BAE-IAP Ar. Umar Saeed, Registrar Ar. / Plnr. Tahira Sadia Fazli and Education Nominee Prof. Dr. Saima Gulzar. Agenda of the meeting was emailed to HODs' prior meeting

1. The meeting was started with the recitation of Holy Quran and Chairman PCATP Ar. M. Arif Changezi welcomed the

- participants and thanked Chairman IAP & BAE for their support and presence. He gave a brief introduction about stance, role and standing of PCATP towards education system based on its by-laws.
- 2. Registrar Ar. / Plnr. Tahira Sadia Fazli discussed about the role of Education Nominee and how PCATP facilitates through Education Nominee. The reason behind the delay that institutes face in the accreditation process i.e unavailability of Accreditation Board members, any issue faced regarding the accreditation should be mailed to the Registrar. Other concerns related to salaries, promotion etc should be inquired from Education Nominee Dr. Saima Gulzar.
- 3. Furthermore, Ar. / Plnr. Tahira Sadia Fazli gave an overview of CPD points and any query regarding CPD points shall be forwarded to Vice Chairman Architecture Muhammad Igbal.
- 4. Chairman PCATP Ar. M. Arif Changezi explained the structure of Accreditation board and cleared that the decision is made according to the Board. Every suggestion or change that's been given to PCATP has to go through AGM (Annual General Meeting) and EGM (Extraordinary General Meeting) before its implementation.
- 5. Chairman BAE-IAP Ar. Umar Saeed highlighted BAE-IAP's role in facilitating education sector, providing a platform for the Institutes where they can discuss their problems and share their ideas and work collectively for the betterment of education. Moreover, he appreciated the efforts, support and cooperation of PCATP and all the

- stakeholders who always have been responsive and helpful.
- 6. There was vagueness in the selection criteria and background of the Inspector/Evaluators, and it was discussed that the language they use is disrespectful. It was also suggested that the inspector can be selected from the Universities as they are well aware of educational system and challenges.
- 7. Chairman PCATP Ar. M. Arif Changezi explained the selection was made by Executive Committee according to the by-laws and it requires the consent of the Inspector. Inspectors are provided regular training and are tested to improve the standard of visits, workshops are held in Lahore, Karachi and Islamabad to educate them and provide proper guidance. Behavioural issues have been observed, and can be sorted if universities send written feedback to Education Nominee so that authorities can take action. Moreover, there is a communication gap between the Institutes and the Education Nominee that has led to mistrust and uncertainty. The institutes should give their suggestions to the Education Nominee and stay connected so that PCATP can improve educational system and quality.
- 8. Registrar Ar. / Plnr. Tahira Sadia Fazli added that the work is divided amongst the two inspectors to improve the standard of reports and comments. The team of inspectors involve both academic and professional practice background. The inspectors with practice background look into the work of students while academicians observe the matters of academic side.

- 9. It was suggested to involve universities in the selection of the inspectors, so that can give their proposal of candidates for inspector post too according to the bylaws and selection criteria. PEC has legitimate Criteria of Selection of Inspectors that is very transparent and open, it can be referred.
- 10. Ar. Umar Saeed suggested that the meetings intrainstitutes and inter Education Nominee and the Institutes need to be more regularized to strengthen academics. He also added the universities should encourage their students to take part in International Architectural competitions so that they can learn via international aspects. Each university should appoint one faculty member who gathers the competition knowledge and be well aware of the strengths and capabilities of the students.
- 11. The Institutes are unsure of which rule book to follow for old or new batches, and also 2013 manual is still being used and followed. HEC needs to update the curriculum and define proper timeline and batches detail for the rule book implementation.
- 12.It was highlighted that a few Institutes have been given 'Compassionate Based Accreditation' or 'Lenient' while the Institutes have fulfilled all the necessary requirements. It was requested to use the words carefully as it questions the credibility and efforts of the Head and the Institute. Ar. M Arif Changezi understood the Institutes stance and assured to avoid the usage of such words.
- 13.PCATP's visit is always taken very seriously and puts a lot of pressure on the Institute. Descriptive and subjective comments sometimes are very misleading, so it was

- suggested that the response can be in numerical form to avoid such miscommunication issues.
- 14. Tier system circulated by PCATP was a Pilot Project, it was clarified.
- 15. Education Nominee Prof. Dr. Saima Gulzar emphasized that "Architecture Education" in Pakistan should be established as an Independent Identity, faculty and Discipline. It is in progress with HEC.
- 16.PCATP announced Professor of Practice rule to be introduced soon. As there is felt a shortage of faculty in the Institutes. POP is important as they can contribute in quality learning of the students and fill in the gap between Academics and the Industry/Profession. Further, it was proposed that POP can be hired on Visiting faculty posts so they can educate the students about the latest trends in the profession.
- 17. Journal List should be updated on the website as there are a few HEC recognized Architectural journals. PCATP website needs to be updated and a FAQ section shall be added as it will be helpful for everyone.
- 18. Registrar Ar. / Plnr. Tahira Sadia Fazli proposed to provide trainings to the School of Architecture related accreditation process and queries.
- 19. Mathematics subject made to be compulsory by PCATP for the students applying for Bachelors in Architecture degree.
- 20. A proposal was suggested to alter the semester system to annual system for Architecture as it is felt to be more feasible and workable.
- 21. A clarity over succession plan was provided that covers up the how a department functions, who takes over, and

similar queries; if a Head of the Department leaves the university.

Teachers' Training Workshop – October 2022

BAE-IAP in collaboration with PCATP and CECOS University organized a Two-Days Teachers' Training Workshop on outcome-based education at CECOS University, Architecture Department. It was conducted by Ar. Uzma Kabir and Ar. Sannah Ejaz.

HODs Meeting with CAA President-Peter Oborn

BAE-IAP organized a meeting of CAA (Commonwealth Association of Architects) President, Peter Oborn with Lahore based Institutes' HODs and their representatives to discuss ideas related to Architectural Education & Collaborations to enhance and improve Education System and procedure. As CAA is valued as a means of accelerating improvement in the world's living conditions and to ensure a sustainable future for the planet and it works to ensure the maximum participation of the architectural profession at all levels. It was a great opportunity for the representatives to get involved, learn about International Architectural development and growth and incorporate them in Education and Profession.
