The President and the Members of the National Council Institute of Architects Pakistan (IAP) are pleased to announce the IAP Design Excellence Awards 2024. This year these Awards are being organized by the National Council. The aim of these Awards is to encourage and acknowledge exemplary architectural work done by Architects in Pakistan. These nation-wide Excellence Awards are open to all IAP Members in good standing. The main objective of these Awards is to inspire architecture in harmony with the unique cultural values and national aspirations. This will encourage awareness and enhance the role of the profession of architecture and architects in the socio-economic and cultural life of our country.

CATEGORIES OF AWARDS

The **FOURTEEN** Categories under which the Awards shall be considered in the 2024 cycle are:

13	F	YOUNG ARCHITECTS AWARDS Best entry submitted for the above categories by member less than 40 years of age at the time of First Submission.
14	G	SPECIAL DESIGN AWARDS Given to entries that, by virtue of their function, size, and scale, do not fit into any of the above-mentioned categories. Designs like public toilets, bus stops, roundabouts, kiosks, installations, and public squares are some projects amongst the many others that can be submitted.

In each category the winner selected by the Jury of Assessors shall be eligible for an Excellence Award.

ELIGIBILITY

Each entrant should be a Member of IAP in good standing, whether living in Pakistan or abroad. However, the building projects should be located within the geographical boundaries of Pakistan.

The entries must fulfil all conditions of submission as specified in the Awards Rules and Regulations. All projects submitted for consideration shall be completed and fully in operation for at least **TWO years** prior to the closing date of submission.

JURY OF ASSESSORS

As per the Rules and Regulations, the National Council is pleased to appoint the following Jury of Assessors for the Awards.

The decisions of the jury shall be final and shall not be subject to any appeal.

NUMBER OF ENTRIES

The entry shall be submitted directly to the Convenor at the specified address on or before the deadline set for various submissions.

IAP Members may submit entries in any or all the listed categories. The number of entries in each category shall however be limited to **ONE Building per category per applicant**.

SUBMISSION REQUIREMENTS

ENTRY FEE

The entries shall be submitted to the Convenor IAP Awards along with payment of a non-refundable Entry Fee of **Rs. 10,000.00** per entry via online payment to the following account. Proof of payment should be submitted along with each entry.

STAGES OF SUBMISSION

The submission will be in two stages:

FIRST STAGE

In the first stage the following material is required to be submitted for each entry in hard and soft copies (PDF):

1. One copy of plans, elevations and in any LEGIBLE scale to explain the project.
2. Six coloured photographs (8"x6") of the project that best convey the essence of the architectural design and features.
3. Use A4 sheet(s) to provide the following information:
 - a. Name of the Architect (or Architects, if jointly responsible for design)
 - b. Name of the Project with address
 - c. Name and Address of the Client (Person managing the project, if the client is a government or corporate agency)
 - d. Dates of commencement, completion, and occupation of the project
 - e. Total covered area of project
 - f. A brief report (not more than 250 words) on the salient features of the project

Each entry shall be sent under separate cover with all the above information.

From amongst the first stage entries the jury may or may not short list one or more projects from each Category for further detailed scrutiny before judgment of the Award is made.

SECOND STAGE

In the second stage, detailed submission in a standard format, to be communicated later to the short-listed entrants, will have to be made by the selected second stage entrants.

Architects whose projects are short-listed shall be informed in writing and they shall then be required to furnish further information, details, drawings, photographs, and soft copies as per requirement of the Awards and as requested by the Jury of Assessors for its deliberations and

adjudication of the Awards.

The Award Jury may, at its sole discretion, not shortlist or makes recommendations for the Award to any or all the project submitted to it under any or all the Categories and its decisions will be deemed final and binding.

All entries must reach the Convenor IAP Awards by **5:00 pm** on the dates specified. No extension should be expected or will be granted.
